## <u>INTERNATIONAL JUSTICE</u> COURSE EVALUATION – SUMMARY

All students in the course anonymously provided responses to the evaluation. Below are the ratings and illustrative quotations from these evaluations.

<u>Course Content and Evaluation</u>: This rating combined prompts about whether readings and lectures were well integrated, readings were appropriate and useful, lectures were intellectually stimulating, and the course as a whole was intellectually stimulating. The students' average rating—on a scale of 1 to 5, with 5 meaning "Agree Strongly"—was a perfect <u>5.0</u>.

<u>Teaching Evaluation – Zachary Kaufman</u>: This rating combined prompts about whether the instructor was accessible and helpful outside class, the instructor was clear in presenting material, and the instructor was overall an effective teacher. The students' average rating—on a scale of 1 to 5, with 5 meaning "Agree Strongly"—was also a perfect <u>5.0</u>.
